FORUM LEARNING OBJECTIVES

- 1. Recognize the heterogeneous nature of PsA, and describe how disease manifestations and comorbidities can contribute to a complex, individual burden of disease
- 2. Describe how patients with moderate/oligoarticular PsA (oPsA) may have limited joint involvement but still exhibit a substantial burden of disease, which can impact their quality of life (QoL)
- 3. Highlight the importance of accurate assessment of disease severity in patients with moderate PsA/oPsA to enable early clinical intervention and appropriate clinical decision-making
- 4. Outline the need for a tailored approach to the management and treatment of patients with PsA, where shared decision-making between patients and healthcare professionals (HCPs) ensures that treatment decisions and goals are individualized and patient focused
